Supervisor: \$15,000 per year.

## Resolution 2022-3 was offered by S. Schafer supported by E. Marvel. It shall be as follows:

Trustee: \$1,200 per year salary. \$100 per meeting per diem will remain the same.

Deputy Hourly Wage Increase: \$15 per hour.
