#### REPORTS:

<u>Fire Dept:</u> V. Feldpausch stated the department received two bids and costs will be \$357,000 less than original numbers due to the type of cab; calls are down and some members starting up classes in July.

<u>Clerk:</u> T. Koenigsknecht and Deputy Clerk have been very busy with absentee ballot applications and coordinating printing of ballot envelopes; completed Par Plan insurance renewal; filled out paperwork for \$2863 reimbursement for Presidential Primary election costs; ordered township drop box and V. Feldpausch installed it; met with Patti Schafer to prepare for audit; GF balanced and ready for audit which is scheduled for end of June.

<u>Treasurer:</u> A. Schafer stated she has been working with Patti Schafer for pre-audit work; working on summer taxes/newsletter to go out July 1<sup>st</sup> and is waiting for call from Pam at Huntington Bank.

<u>Supervisor:</u> V. Feldpausch has been working with Clinton County Road Commission Bruce Wirth and Drain Commissioner Hanses on \$22,000 drain work and working on application for a DNR grant.

#### **NEW BUSINESS:**

1. <u>County Commissioners Report:</u> Commissioner Pohl was absent; however, he emailed the Clerk the following report. The Emergency Declaration remains in place up to the end of June; MMDHD has been heavily engaged in managing COVID-19 outbreak; as of this morning there have been 139 cases and 11 deaths in Clinton County; County Sheriff's Office/Jail has maintained a COVID-19-free operation; Motz Park and Clinton Lakes park opened; Remonumentation continues; tax foreclosure has been extended to June 29, 2020 and delinquent dog license penalty waived for 2020; courts preparing to increase activity June 1st; CCRC operating at near normal; County is moving forward with the bond sale and equipment contracts for upgrades to Central Dispatch.
